Each traveler will need a Fit to Fly health certificate dated no more than 72-hours before the flight leaving the U.S. to show when checking in with the airline. 2. Each traveler need to submit his or her consent letter for the state quarantine for the period of 14 days upon their registration for the issuance of the certificate of entry to the Kingdom of Thailand. They also need to carry one with them upon entering the Kingdom. 3. Another important document is the T.8 document (attachment) to be submitted as a hardcopy as well as through an online application.
